

The Wedge Family Fun Run Walk Giveaway: COMPETITION TERMS AND CONDITIONS

2. 3. By entering this competition, you accept and agree to the following terms and conditions which will govern the competition. Furthermore, you verify that you are unaware of any reason legally prohibiting you from entering this competition and, if the competition requires the submission of photographs, artwork or images of people, or of anything else that requires consent or copyright, that you have the necessary consent and authority to do so if required.
